

NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of ***“Improvement & Revamping of Water Supply, Power Supply & Sewerage Networks at Goa Medical College Complex, Bambolim Goa- Phase II: Fire Fighting Work SH: Inspection and Overhauling of Fire Fighting Room Machinery (Old Building).”***. The sealed quotations shall be received *upto 15:00 hours on 26th December 2018* and the same will be opened at *15:30 hours* on the same day. The estimated cost for the work is **Rs.4,68,125.00.00**

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by as per the enclosed **ANNEXURE-I** while submitting the quotation. Rates shall be exclusive of taxes. All the pages of **ANNEXURE-I** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.9,365.00** in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected. The detail scope of work is enclosed at **ANNEXURE-III**.

A Contractor having executed works of Fire Fighting (Hydrant/ Detection system) may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be ***up to 24th December 2018 at 17:30 hours***.

The security deposit shall be collected by deduction from the bill at the rate of 5% and the Earnest Money Deposit will be treated as a part of Security Deposit. The security deposit shall be released on successful completion of 12 months from the date of completion of the work.

Defect liability period (DLP) will exist for the period of one year after completion of the project. During DLP, any breakdown calls has to be attended immediately and free of cost, failing to attend the call, Security Deposit will be forfeited.

The work period shall be of 45 days and will commence from the 10th day after the date of issue of Work Order / Letter of Acceptance.

GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
