

NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from eligible bidders for the work of “**Additional Infrastructure works for Goa Medical College, Bambolim, Goa SH: Demolition and construction of Hospital and Hostel at Mandur, Goa -Supply and Installation of Fibre Sculpture of logo of Goa Medical College**”. The sealed quotations shall be received upto 15:00 hours on **21st January 2019** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is Rs.3,00,000.00.

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I, ANNEXURE-II, ANNEXURE-III** shall be duly stamped and signed. The general terms and conditions, drawing and list of approved brands are furnished in **ANNEXURE-III**.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs.6000.00 (Rupees Six thousand only) in the form of Demand Draft from a Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected. The EMD of the successful bidder shall be appropriated as security deposit and shall be refunded after supply of Sculpture.

Bidders may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **18th January 2019 upto 17:30 hours**.

In case of delay, the successful bidder shall be liable to pay to the Employer an amount of **Rs.800/-** (Rupees Eight Hundred only) per day as Liquidated Damages for default for every day. However, such total amount as Liquidated Damages shall not exceed 10% of the original quotation price.

The work shall be completed within **two months** from the tenth day of issue of Work Order / Letter of Acceptance.

GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
