## **SECTION - I**

### **INVITATION NOTICE FOR EMPANELMENT OF CONSULTANTS FOR INFRASTRUCTURE WORKS IN GOA.**

- 1.0 Applications are invited for empanelment of **eligible consultants** experienced in Architectural services / preparation of DPR / planning, design, estimation, preparation of tender documents, evaluation of tenders, project management, proof checking etc., of infrastructure works such as bridges, flyovers, roads, highways including expressways and all types of building works such as hospital complexes, bus stands, market complexes and malls, international convention centers, IT Parks, sports complexes, institutional / offices complexes, Kala Bhavans, Kala Academy, Sahitya Academy, Sangeet and Natak Academy, Town halls, Community halls, libraries, museums, all types of planning like city planning, traffic planning, innovative designs, landscaping and other miscellaneous works, Structural Audit & Consultancy for existing structures, specialized lighting consultancy and consultancy for Interior works.
- 2.0 GSIDC Ltd. intends to take up large number of infrastructure works of above nature and thus all types of consultancy services are required for works of various values.
- 3.0 The application forms are available on the GSIDC website and can be downloaded by the Applicants. The applications received will be scrutinized on a monthly basis.
- 4.0 The application should be submitted with all the documents superscribed on the envelope with the words **“APPLICATION FOR EMPANELMENT AS CONSULTANTS”**.
- 5.0 Any other information and clarification concerning the application can be had from the office of Goa State Infrastructure Development Corporation Ltd., 7<sup>th</sup> Floor, EDC House, Dr. Atmaram Borkar Road, Panaji, Goa either in person or through Telephone Nos. (0832) 2493550-59, facsimile : (0832) 2493577 / E-mail : [email@gsidcltd.com](mailto:email@gsidcltd.com).
- 6.0 The applicant when empanelled as a Consultant should have their own office in Goa within a stipulated reasonable time after the allotment of any work.

- 7.0 Consultants may associate with other experts/Consultants to enhance their qualifications and for better service enablement and to provide multi-disciplinary services to GSIDC Ltd. once they are empanelled. However, joint venture is not allowed.
- 8.0 The right to reject any or all applications without assigning any reason is reserved by GSIDC Ltd.
- 9.0 ***The Consultants who were empanelled earlier by the Corporation against advertisement dated 5<sup>th</sup> July 2012 and subsequent addendum dated 20<sup>th</sup> July 2012 need not apply in response to this notice as the purpose of this notice is to have additional empanelment of Consultants. However, empanelled consultants who wish to be empanelled under an upgraded class or a different category will have to apply afresh by making payment of prescribed processing fee.***
- 10.0 On receipt of applications and after proper evaluation, the qualifying Consultants will be empanelled in different categories and for different values based on their experience and financial strength. The applicants may indicate their choice of category / categories to be empanelled by giving (✓) tick in the Letter of Transmittal. The GSIDC Limited reserves the right to empanel the Consultants in the appropriate category and class.
- 11.0 The **empanelment will be initially for a period of 3 years or till fresh empanelment is done whichever is earlier.** However, the empanelment can be renewed after 3 years if the GSIDC Limited so desires.
- 12.0 Pre-qualification/Empanelment does not necessarily mean that a job will be assigned to the Consultant.
- 13.0 Further communication / clarifications, will be made with the applicants if found essential before empanelment.
- 14.0 All information submitted will be the property of GSIDC Ltd. and will not be returned.

## SECTION - II

### INFORMATION AND INSTRUCTION TO APPLICANTS:

#### 1.0 GENERAL :

- 1.1 All information requested for in the enclosed forms should be furnished against the respective columns in the format. If information is furnished in separate documents reference to the same shall be given against the respective column. If information is 'Nil' it shall also be mentioned as 'Nil' or 'No such case'. If particular query is not applicable in case of the applicant it shall be stated as 'Not applicable'. No columns should be left blank. However, the applicants are cautioned that non-submission of complete information called for in the required formats, or making any change in the prescribed forms may result in the application being summarily rejected.
- 1.2 All information must be submitted in English.
- 1.3 The application shall be type written. The applicant's name, signature and stamp shall appear on each page of the application form.
- 1.4 Overwriting shall be avoided. Corrections, if any, shall be made by crossing out, initialed with date and rewritten. ***The application form as downloaded from the website of GSIDC Ltd., only shall be submitted.***
- 1.5 Copies of the References, information, ***work orders and completion certificates from the respective clients*** certifying the suitability, technical know-how, ***experience*** or capability of the applicant shall be submitted by the applicant, which could be verified by GSIDC Ltd., when required.
- 1.6 The applicants are advised to attach any additional information which he thinks fit and necessary in regard to proving his capabilities. No further information will be entertained after submission of the application unless it is called for by the GSIDC Ltd.
- 1.7 Application form duly completed and signed shall be submitted in a sealed cover. The sealed cover superscribed as "APPLICATION FOR EMPANELMENT AS CONSULTANTS FOR INFRASTRUCTURE WORKS

IN GSIDC LIMITED” shall be received by the Goa State Infrastructure Development Corporation Ltd., Panaji, Goa during working hours on all working days.

- 1.8 Consultants who wish to submit the application shall submit the application with a processing fee (non refundable) of Rs.20,000/- (Rupees twenty thousand only).
- 1.9 The processing fee shall be paid along with the application form in the form of crossed Demand Draft payable at Panaji, Goa from a Nationalised Bank drawn in favour of “Goa State Infrastructure Development Corporation Limited”. ***Applications received without processing fee shall not be considered.***
- 1.10 The cost incurred by the applicants in preparing and submitting this application, in providing clarification or attending discussions, conferences in connection with process of empanelment shall be borne by the applicant and the Corporation in no case will be responsible or liable for these costs regardless of the conduct or outcome of the process.

## **2.0 DEFINITIONS :**

- 2.1 In this document the following words and expressions have the meaning hereby assigned to them.
- 2.2 **EMPLOYER** means the Goa State Infrastructure Development Corporation Ltd., Panaji Goa.
- 2.3 **APPLICANT** means individual, proprietary firm, firm in partnership, limited company.

## **3.0 METHOD OF APPLYING :**

- 3.1 If the application is made by a proprietary firm, it shall be signed by the Proprietor above his full typewritten name and full name of his firm with the current address.
- 3.2 If the application is made by a firm in partnership, it shall be signed by all the partners of the firm above their full typewritten names and current addresses or alternatively by a partner holding Power of

Attorney for signing the application, in which case a certified copy of Partnership Deed shall accompany the application.

- 3.3 If the application is made by a Limited Company, it shall be signed by a duly authorized person holding the Power of Attorney for signing the application, in which case a certified copy of the Power of Attorney issued by the Board of Directors shall accompany the application.
- 3.4 An independently empanelled applicant may subsequently strengthen his capacity by association with another prequalified applicant or any other consultant of repute for specialized services, but should seek the prior approval of the Goa State Infrastructure Development Corporation Ltd., for such association. However, the Lead Consultants only will be responsible to GSIDC Ltd., and the Lead Consultant shall sign the agreement with GSIDC Ltd., for the contractual obligations.

#### **4.0 FINAL DECISION MAKING AUTHORITY :**

- 4.1 The Employer reserves the right to reject or accept any one or all applications and to annul the process and reject all the applications at any time without assigning any reason(s) thereof and without thereby incurring any liability to the affected applicant or without informing the applicants of the grounds for the Employer's action.

#### **5.0 ELIGIBILITY AND MINIMUM CRITERIA FOR EMPANELMENT :**

- 5.1 This invitation is open to applicants permitted to carry on business in India and having office anywhere in India for the last 5 years.
- 5.2 To be eligible for empanelment the applicant shall provide evidence satisfactorily to the Employer of their eligibility and of their capability and adequacy of resources to carry out the services. To this end, all applications submitted shall include the following information :
- 5.2.1 Letter of Transmittal.
- 5.2.2 Copies of original documents defining the construction or legal status, structure of organization, place of business of the Company or Firm or Partnership - **SCHEDULE 'A'**.



- 5.2.3 The financial status of the applicant shall be furnished - **SCHEDULE 'B1'**. Information regarding turnover of the last three consecutive years of the Company category wise shall be furnished - **SCHEDULE 'B2'**
- 5.2.4 The qualification and experience of key personnel with the applicant - **SCHEDULE 'C'**.
- 5.2.5 Details of the experience and past performance of the applicant on works within the past five years and details of current works in hand and other commitments - **SCHEDULE 'D'**.
- 5.2.6 Brief details of best 3 projects of the categories such as roads, bridges, buildings, etc., as mentioned in para 1.0, completed or in progress - **SCHEDULE 'E'**.
- 5.2.7 Information in brief - **SCHEDULE 'F'** and any other relevant additional information - **SCHEDULE 'G'**.
- 5.2.8 ***All the information furnished in the above schedules should be substantiated with documentary evidence.***

**5.3 CATEGORIES OF EMPANELMENT AND MINIMUM QUALIFICATION CRITERIA.**

5.3.1 Empanelment will be made in the following categories :

CATEGORY-1	:	Bridges, Roads and Highways.
CATEGORY-2	:	Building works like Hospital, Market, Institutional and Office Building complexes etc.
CATEGORY-3	:	International Convention Centres, IT Parks, Malls, Sports Complexes, Bus Stands.
CATEGORY-4	:	All types of planning including City planning and Traffic planning, innovative designs, landscaping and other miscellaneous works.
CATEGORY-5	:	Structural Audit & Consultancy for existing structures.
CATEGORY-6	:	Specialized Lighting Consultancy.
CATEGORY-7	:	Interiors

5.3.2 The classification of infrastructure works depending upon the cost of work will be as given below :-

- CLASS – A : Above Rs.150 crore.
- CLASS – B : Above Rs.50 crore and upto Rs.150 crore.
- CLASS – C : Above Rs.10 crore and upto Rs.50 crore.
- CLASS – D : Upto Rs.10 crore.

5.3.3 For the purpose of empanelment applicant shall meet the following criteria as a minimum.

5.3.3.1 The applicant shall have minimum average annualized financial turnover for the various classes as given below :-

- CLASS – A : Rs.15.00 crore
- CLASS – B : Rs.5.00 crore
- CLASS – C : Rs.1.50 crore
- CLASS – D : Rs.25.00 lac

5.3.3.2 For empanelment in a particular category, the applicant should have a turnover of atleast 50% of the amounts indicated for various classes of Consultants in Para 5.3.3.1 i.e. For eg. For an applicant to qualify under Class-A in Category-1, he should have atleast Rs.7.50 crore in that category even though he has turnover of Rs.15.00 crore or more.

For applicants who are subsidiaries of foreign companies (Equity of Foreign entity more than 50%) and if their turnover are claimed, the GSIDC shall insist a letter from the Parent Company to make their services available to Indian Company as required and demanded by GSIDC without any extra financial liabilities.

5.3.3.3 The applicant must be a well established consultant for more than 5 years having experience in conceptualizing/ planning/engineering/design/proof checking, preparing feasibility reports, design and estimation, preparation of architectural / structural drawings, preparation of tender documents, evaluation of tenders, comprehensive project management with quality and quantity survey, preparation of bills etc. of the work (s) in the respective category.

5.3.3.4 The applicant should have regular set up of a team of Architects/Engineers having sufficient experience.

5.3.3.5 The applicant shall be able to hire the services of some other suitable consulting agencies for specialized jobs such as internal and external electrification, plumbing, lifts / elevators, air conditioners, Operation theatres, acoustics/ sound system fire fighting, audio visual, networking, stage craft, medical / non- medical equipments, hospital / non-hospital furniture, medical gas, etc.

5.3.4 Even though applicants satisfy the necessary requirements they are subject to disqualification if they have :

(i) Made untrue or false representation in the form, statements required in the application document.

(ii) Records of poor performance such as abandoning work, not properly completing contract, financial failures or delayed completion.

5.3.5 It may be noted that after empanelment, works shall be allotted to various consultants commensurate to their capabilities and capacities as assessed by GSIDC Ltd. No representation in this respect will be entertained.

5.4 For the purpose of empanelment, applications received will be evaluated based on the details furnished and minimum criteria specified by the GSIDC Limited in para 5.3 above. Further, ***the Consultants who had applied already and were/are in the services of the Corporation will be evaluated based on their past performance.***

## **6.0 AWARD CRITERIA :**

After the empanelment the successful applicants will be intimated about the empanelment with ***Goa State Infrastructure Development Corporation Limited.***

The allotment of work will be done to the empanelled consultants by inviting financial bids amongst the empanelled consultants or through any other transparent method. The Consultants will also be allowed to quote for the works one class below the class in which they are empanelled. For eg.

Consultant empanelled in Class-A shall be entitled to quote for the works under Class-B but will not be allowed to quote for works under Class-C and Class-D. The empanelled Consultants will be allotted works of aggregate value upto twice the upper limit of the class in which the Consultant is empanelled, except for Class-A. The aggregate value for Class-A will be as per the discretion of GSIDC. However, GSIDC reserves the right to give additional 25% of the aggregate limit of the value for the Consultant in Class-B, C and D if the performance of the Consultant is found satisfactory. The Corporation also reserves the right to allot the work to any of the empanelled Consultant after giving due consideration to the suitability and competence of the Consultant to handle jobs on a fixed cost under special circumstances, with due regard to their proven track record, which shall be reviewed by the Corporation (employer), as found necessary, from time to time.
