The highest bidder is required to deposit his entire bid amount by Demand Draft drawn in favour of Director, Directorate of Sports and Youth affairs, Campal, Panaji, Goa, within 48 hours. The successful bidder shall have to pay Goods & Service Tax (GST) as applicable.

The material shall be removed within fifteen days by the successful bidder, failing which the GSIDC is authorized to take further necessary action in this regard and the bidder shall not have any claim on the material. The upset price of the said material fixed for Auction is Rs.1,37,458.00 [Rupees One Lakh Thirty-Seven Thousand Four Hundred Fifty - Eight only].
