### SHORT NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of *“Renovation/Maintenance of Hospitals, CHCs, PHCs, RMDs under Directorate of Health Services in North Goa S.II.: Replacement of Oxygen terminal outlets of Medical Gas Distribution System at North Goa District Hospital, Mapusa”*. The sealed quotations shall be received *upto 15:00 hours on 4<sup>th</sup> May 2021* and the same will be opened at *15:30 hours* on the same day. The estimated cost for the work is **Rs.5,40,000.00**

The Schedule of Quantities including the description of the item is furnished in ANNEXURE-I enclosed herewith. The bidders shall submit their offer by as per the enclosed ANNEXURE-I while submitting the quotation. Rates shall be exclusive of taxes. All the pages of ANNEXURE-I shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.10,800.00** in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at ANNEXURE-II, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected. The detail scope of work is enclosed at ANNEXURE-III.

A Contractor having executed works of Medical Gas line system of hospital may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be *3<sup>rd</sup> May 2021 up to 17:30 hours*.

The security deposit shall be collected by deduction from the bill at the rate of 5% and the Earnest Money Deposit will be treated as a part of Security Deposit. The security deposit shall

be released on successful completion of Defect Liability Period of 12 months from the date of completion of the work.

The work period shall be of 10 days and will commence from the 10<sup>th</sup> day after the date of issue of Work Order / Letter of Acceptance.
