Sealed Item Rate quotations are invited from the eligible contractors/authorized dealers & service providers for the work of **"Repair of 500 LPD Solar Water Heaters at Girls Hostel, Goa Medical College, Bambolim, Goa."** The sealed quotation shall be received upto 15:00 hours on **29th September, 2023** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.98,000.00**.

The Schedule of Quantities including the description of the item is furnished in **Annexure-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **Annexure-I** while submitting the quotation. Rates shall be inclusive of all taxes except GST. GST will be paid extra as applicable at the time of billing. The general terms and conditions are furnished in **Annexure-III**. The quotation without the accompanying EMD in the specified format shall be summarily rejected.
