NOTICE INVITING QUOTATION

Goa State Infrastructure Development Corporation Limited (GSIDC) invites sealed quotations on item rate basis for the work of "Supply, Installation, Testing and Commissioning of Tablets (Tabs) for the Corporation". The sealed quotations shall be received upto 15:00 hours on 16th December, 2025 and the same will be opened at 15:30 hours on the same day. The estimated cost of the work is Rs. 5,48,728.80

The Schedule of Quantities including the description of the item is furnished in Annexure — I which is enclosed herewith. The bidders shall submit their offer by indicating rates for the items as per the enclosed Annexure — I while submitting the quotation. Rates shall be inclusive of all taxes and all other levies except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate. The rates shall be quoted in words as well as in figures. In case of discrepancy between the two, the rates in words will prevail over the figures. All the pages of Annexure — I & II shall be duly stamped and signed. Offers submitted with any special conditions are liable for rejection.

The bid shall be submitted in sealed envelope marked as follows:

- (i) Original copies of Annexure-I (obtained from GSIDC office) duly filled, signed and stamped.
- (ii) Original copy of Annexure II on company letter head duly filled, signed and stamped.

The envelope shall be sealed and super scribed along with the title "Supply, Installation, Testing and Commissioning of Tablets (Tabs) for the Corporation". and dropped in the Tender Box kept on the 8th Floor, EDC House, Panaji, Goa.

The envelope shall be marked on the left hand bottom corner with full name and address of the bidder written or typed on the envelope. If all envelope is not sealed, super scribed or submitted in any other than mentioned format, GSIDC will assume no responsibility and the bid may be liable for rejection.
