**SHORT NOTICE INVITING QUOTATION**

Sealed Item Rate quotations are invited from the eligible bidders for the work of ***"Providing trapezoidal shaped bituminous speed breakers from Scoop Smile Dental Clinic to Kandola College, Marcel- 2<sup>nd</sup> Call"***. The sealed quotations shall be received **up to 15:00 hours on 28<sup>th</sup> September 2026** and the same will be opened **on same day at 15.30 hours**. The estimated cost for the work is **Rs.8,83,133.00**

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. Rates shall be exclusive of GST. GST will be paid as applicable. All the pages of **ANNEXURE-I** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs. 18000.00 (Rupees Eighteen Thousand Only)** in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. **THIS EMD WILL BE ADJUSTED IN THE SECURITY DEPOSIT RETAINED BY GSIDC**. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

**The Defects Liability Period will be 05 years and therefore total security deposit of 5% will be retained by GSIDC till the completion of Defects Liability Period (05 years) which will be subsequently released upon joint inspection and rectification of defects, if any.**

Bidders in the field of similar work may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of documents shall be **25<sup>th</sup> September 2026 up to 16.00 hours**.

The work shall commence from the date of issue of Letter of Acceptance / Work Order.

The **time period** for carrying out the work is **01 (one) month** including monsoons.
